Despite Mr. Ewell's multiple requests, a sergeant declined to report to the scene and agreed with Officer Ricafrente over the telephone that a citation should indeed be issued, despite Mr. Ewell being unaware that his license plate had been unknowingly switched with that of another similar vehicle.
