In addition, Complainant claims his bag was searched out of his sight. While at the Clark County Detention Center, Complainant asserts he was placed in a cell in which the toilet was overflowing with urine and feces, and that water was withheld from him during his stay; and, if appropriate, to privately consider and vote upon the findings and recommendations to be made to the department regarding any disciplinary action against the officers.
