Mr. Fields further asserts that one of the officers mocked him, questioned why he was missing teeth, and continued to antagonize him by speaking in a high-pitched, mocking tone; and, if appropriate, to privately consider and vote upon the recommendations to be made to the department regarding any disciplinary action against the officer(s).
